Venue: RAI Amsterdam Convention Centre, the Netherlands. Date: 28-29 September, 2016
Travel time for the Expo will be for 6 days and 5 nights from 26th September to 1st October 2016

Considering the European Famous Expo Venue Rent, Standard Stall Making, Event Management cost, Promotion cost in the Netherlands and Bangladesh, etc. the actual cost for Per Exhibitor is **BDTk.5,51,200/-.** DBCCI is providing subsidy of BDTk.3,56,200/- for Per Exhibitor to promote Bangladeshi Export to the European Market. Therefore, Per Exhibitor's contribution for the Venue, Stall, Event Management and Promotion will be BDTk.1,95,000/- only **without** air ticket and hotel accommodation.

Furthermore, making an allowance for the European Famous Seminar Venue Rent, B2B and Event Arrangement cost, Promotion cost in the Netherlands and Bangladesh, etc. the actual cost for Per Delegate is **BDTk.3,60,000/-.** DBCCI is providing subsidy of BDTk.65,000/- for Per Delegate to attract European Investment in Bangladesh. Consequently, Delegate fee for the Seminar Venue, B2B & Event Arrangement and Promotion will be BDTk.2,95,000/- only **including** air ticket and hotel accommodation.
