Dear Members and Colleagues, Assalamu Alaikum,

Your kind attention is drawn to the above matter mentioned in the subject. You are aware that there is no alternative to unhindered import of raw materials, machinery/parts for smooth functioning of country's export-oriented industries to deal with the situation arising out of the post-corona economic crisis and the Russia-Ukraine war. In view of the above, Bangladesh Bank constituted Export Facilitation Fund of Tk 10,000 crore, Green Transformation Fund of Tk 5,000 crore, Pre-shipment Credit Scheme of Tk 5,000 crore. So far 05 state-owned commercial banks, 01 specialized bank, 41 private commercial banks and 04 foreign commercial banks affiliated to Bangladesh Bank, have signed agreements with Bangladesh Bank for providing loans from these funds (Copy enclosed).

Your concerned lien banks those have not yet signed the said agreement with Bangladesh Bank are requested through you to do so for providing loans to their concerned clients from above funds/scheme.

Hopefully you will have special advantage in importing raw materials, machinery/parts through loan from above mentioned low interest funds/scheme of Bangladesh Bank.
